Introduction

Cheshire Fire Authority undertook a consultation on its proposed increase in its precept for the 2023/2024 financial year. The consultation took place between 22 December 2022 and 23 January 2023. As part of the consultation, respondents were asked to provide any additional comments that they may have.

A total of 339 comments were provided and are included within this document. Please note that comments such as N/A, “nothing further to add” or “no comments” have not been included within the report. In addition, no amendments have been made to correct any error in spelling or grammar within the original comments.

Free Text Comments

- Raising tax is fine, bit please be strategic in use and search for savings - especially for example those that have a combined benefit of savings and for the planet eg reducing energy, fuel and water consumption
- Although I strongly support the additional funding for fire service allowing them to maintain the service they now provide, I feel the government should increase their contribution towards the additional amount of funding required and not expect Council Tax payers to step up and pay any deficit in funding, looking at the economic climate and the way it is affecting most family's financially today.

- I would prefer not to pay an increase but in these times, I want to make sure that everyone is safe
- Too many people in this country want great services but not pay for them. Totally agree the precept should increase.
- Go for it. We need a decent fire service.
- Does not seem too unreasonable in current economy
- No think the increase would ensure fair pay to all workers whilst maintaining high standards in terms of training, equipment and community support
- I am happy to pay more tax for public services
- somebody has to pay! Given current situation 6% does not seem excessive
- Cheshire Fire and Rescue have helped to control its budget over many years without making inflation busting increases passed on to local council taxpayers each year. So its acceptable increase of around 6% for Band D properties or an extra £5 per year. This Government have created the role of PCC for Cheshire Police. This new role and department is just another way of increasing ways of extracting more local appointed tax collector. The PCC powers of increasing massive increases each and every year beyond the ONS CPI inflation since this role was created. The CF&RS have been excellent in managing their budgets by good management. The same cannot be said by the Cheshire Police Crime Commissioners

- We need to have the latest equipment and trained professionals to keep us safe the increase is nothing .
- Clarity on exactly how this extra money is spent.

- My house has had no fire significant fire cover over Christmas due to insufficient staffing - appliances off the run
- If you can't keep fire appliances and special appliances on the run at the moment, can you guarantee availability with this proposed increase?
- As a cheshire resident i am concerned about the deficiencies in staffing, especially at the sharp end of the service...where is really matters, where life and property might be saved. It appears there was a failure to maintain staffing at certain fire stations during the Xmas 2022 period. So any increases in funding in Cheshire needs to be allocated to the front line of the service to ensure fire appliances remain available 24/7 throughout the county....to prioritise the safety of Cheshire residents!
- I have seen a real terms increase year on year, yet am astounded when I hear of fire stations being closed for a night or day shift!

- Too much effort undertaken on non traditional fire service activities that we should not be paying for when we don't want them
- Support dependent on the Authority's plan being able to provide an inflation equally pay rise for staff.
- Make sure the money goes into people's pockets
- The firefighters deserve a pay rise at least in line with inflation
- Increases will probably be used for pay rises which further increases inflation
- I am concerned as to whether it is sufficient given the level of inflation and the need to pay firefighters adequately.
- Use the money to improve fire fighter salaries instead of trying to fund amateurs to do the job when the professionals strike
- Pay support staff the same wage as operational.
- Fire fighters are underpaid for the job they do. We need to pay them for all the risks they take on a daily basis
- Give the staff an actual pay rise instead of an annual pay cut for once.
- Everything needs to be fully funded including wages.
- ALL front line services should be rightly rewarded for the work they do. I have been part of the blue light family for 14 years and we have been systematically overlooked and ignored
- I strongly oppose the increase as Cheshire Fire & Rescue Service must use finances better e.g. 1. Stop the Co-responder scheme that attends medical emergencies as The NHS Ambulance Service is paid for from National Insurance contributions, CF&RS is using the council Tax to pay for the Co-responder service which I consider as a misuse of council Tax and Public Funds. e.g. CF&RS has attended the Pride Event in Manchester wrapping fire engines and other vehicles and buying resources for the events. Manchester is not in Cheshire and the attendance of this event should not be paid for by Cheshire residents, again; a misuse of council Tax and Public Funds.

- You should be honest and make it clear this is a 6% increase on Band D - higher than the council will be allowed. It is not long since you returned to a situation of having 3 senior officers paid £100K plus (as well as a vehicle), and the Chief Fire Officer receives more than the CEO of the local council - despite that organisation being many times bigger.
- I am not opposed to an increase, but an increase to 5% for a band D is a little high
- why does the budget have to be one year- if could be better phased over two, hoping inflation reduces over time in particular
- Why weren't you up front in saying that the increase is 6% instead of 2% in previous years? Saying an increase of £5 for Band D is not being up front about the true increase that has been applied across the board.
- Should increase higher bands and reduce lower
- Why is council tax band used as a measure of how often services are utilised and how much residents have to pay? A flat rate would be a fairer method.

- I understand the challenges facing public services in general at this time. For transparency purposes I would appreciate a one page summary which breaks down the budget so we have a sense of what the money is required for and the tangible deliverables.
- For Congleton to only have one fire engine and you want to increase prices the town has had thousands of new homes built in last five years or less
- No one owns a chip pan anymore, most fire fighters have second jobs....
- Should be the same amount for each band.
- I think the Fire Service should consider following the American system of amalgamating the Fire and Ambulance Services which would at the very least save on Administrative costs and may even provide a more efficient total service for the public
- It may be too difficult or not allowed to charge more to those on higher bands and therefore lower to those on lower bands.
- A maximum increase of 5% over all bands
- Crewe Town council has put up its tax by 3.45 percent for 2023.
- No fires in my area in living memory
- To All working second jobs and not paying tax
- This could be taken from the Cheshire police and crime commissioner and given to the Cheshire fire authority without an increase in council tax bill for people
- Lack of work generally on a daily basis, make more fire people part time and reduce the top brass wages and hours, they are mere figureheads and a drain on resources.
- Would need to know whether there is any other proposed increase for other services
- We need the fire and rescue service to be able to respond to the needs of Cheshire East's population
- I think the mayoral and Liverpool city region mayoral precepts should be scrapped and given to police and fire
- Yet again there is no specific commitment to improve services in north Cheshire, particularly around the growing Wilmslow, handforth and Alderney Edge conurbations. Most capital investment appears to have gone to Crewe and Chester.
